## NOTIFICATION

Subject: National Means Cum Merit Scholarship Scheme (NMMSS)-inviting Online Applications from candidates of examination year 2021, 2020, 2019, and 2018 for the session 2021-22 on National Scholarship Portal 2.0.

*Online applications are invited from the eligible candidates who have qualified National Means Cum Merit Scholarship (NMMSS) examination held on 24<sup>th</sup> of March, 2022 and are presently reading in Class 9<sup>th</sup>. The application can be submitted on National Scholarship Portal 2.0 (<http://scholarships.gov.in>) by or before 30th of September, 2022.*

- i- Only those students whose family income from all sources is not more than Rs. 3, 50,000/- per annum can apply.
- ii- The students studying in “Kendriya Vidyalayas and Jawahar Navodaya Vidyalayas” are not entitled for said scholarship scheme.
- iii- The quantum of Scholarship is Rs, 12,000/- per annum to selected students of Class IX (9<sup>th</sup>) and their continuation/renewal in Classes X to XII for study in Govt., Govt. aided and Local body schools .

Furthermore, the candidates who have been already granted scholarship on the basis of NMMSS examination in the year 2020, 2019, and 2018 and are presently studying in the class 10<sup>th</sup>, 11<sup>th</sup>, and 12<sup>th</sup> respectively during the session 2022-23 can also submit online applications for renewal of instalments on National Scholarship Portal by or before 30<sup>th</sup> of September, 2022.

The online applications submitted by candidates shall be verified by the concerned School (Level-1 verification) and subsequently Level-2 Verification shall be done by concerned Chief Education Officer.

**Note:** The Heads of the Institutions may get/reset their User ID and Password from concerned Chief Education Officer to verify the students online.
