Sequel to the approval of the Chairman on the resolutions passed by the Affiliation Committee by way of circulation in July, 2021, sanction is hereby accorded to the:-

1. Grant of Extension in the period of affiliation in favour of **101 (One Hundred One)** Private Educational High/Higher Secondary Institutions of Jammu Division for a period of **05 (Five)** years as per the details given in **Annexure -A** and **Annexure -B**.
  - I. **75 cases Extension in Affiliation Annexure -A**
  - II. **26 cases Extension in Affiliation Annexure -B**
2. Grant of **Up-gradation** in favour of **22 (Twenty Two)** Private Educational High/Higher Secondary Institutions of Jammu Division for a period of **02 (Two)** years as per the details given in **Annexure - C** and **Annexure - D**.
  - I. **19 Up-gradation in Affiliation cases in Annexure - C**
  - II. **03 Up-gradation in Affiliation cases in Annexure - D**
3. Correction in name of one Higher Secondary Institution of Jammu Division as per detail given in **Annexure- E**.
  - I. **01 Case of Correction in name of institution Annexure - E.**

### **Terms & Conditions**

- The affiliation shall strictly be governed by the terms and conditions as laid down in SRO-123 and SRO-292, relevant Govt. orders, JK BOSE regulations, resolutions passed by the Affiliation Committee in its meetings and the instructions issued by the JKBCSE /Government from time to time.
- The institutions placed in Annexure-"B" and Annexure-"D" having Management Committee Certificate or other deficiencies shall have to address and remove the same within a time period of 06 (six) months, failing which the decision with regard to release of Board facilities to such institutions shall be re-visited.
- There shall be no compromise with safety conditions, therefore three mandatory/ statutory certificates viz. Building Safety certificate, Fire Safety certificate & Chemical Safety certificate by the designated authorities are essential for the consideration of the affiliation.
- It shall be binding upon all Private Institutions to fulfill all the statutory conditions laid down from time to time.
- The Financial transaction including the payment of salary to the staff is to be made through Bank invoice.
- All the Private Educational Institutions shall strictly adhere to the Fee structure fixed by the Fee Fixation Committee of the Government failing which they are liable to be de-affiliated.
- All Schools have to adhere to the condition imposed by the competent authorities for safe transportation of students.
- The Heads of the affiliated Institutions shall keep their Infrastructure viz Examination Hall & related facilities at the disposal of the BOSE as and when needed and especially at the time of the Examinations.
- The Academic calendar prepared by the BOSE is to be strictly adhered; any deviation thereof shall invite imposition of penalty.
- It will be mandatory upon all the academic institutions affiliated with JK BOSE to adopt the Curriculum and Text-Books for all the classes prescribed and published by the JK BOSE.
- To maintain hygiene & sanitation, there should be separate toilets for boys and girls. An additional facility of change room is to be made available to the Girl students and First Aid facilities should also be made available.
- Parent Teacher Association as required under norms has to be there along-with Management Committee to ensure the Academic Development.
- The EPF/CPF (whichever is applicable) is to be maintained with the required contributions towards the fund.

- It shall be obligatory upon all the affiliated Academic Institutions to obtain recognition orders from School Education Department.
- The previous period for which facilities were released provisionally by the BOSE authorities from time to time in favour of the institutions, is also regularized with the condition that the institution/s will deposit affiliation fee for previous period as per BOSE norms.
- All the institutions shall ensure the renewal of all certificates as are envisaged in SRO-292 dated 2<sup>nd</sup> July 2018.
- The institutions that are granted five years extension in affiliation shall deposit an Annual Inspection Fee as notified under JK BoSE norms from time to time for the first three years for determining the academic and infrastructural viability.
- The Academy institutions having transport facility for conveyance of their students and staff shall be bound to produce No Objection certificate from the concerned Regional Transport Officer (RTO). However, the Academic Institutions having no transport facility shall furnish an affidavit in this behalf duly affirmed before the 1<sup>st</sup> Class Magistrate.
- The Director, School Education Jammu/Kashmir shall henceforth forward the affiliation/up-gradation case/s for Joint Inspection of only those Academic Institutions, who fulfill the requisite formalities/possess the required certificates/documents including "Managing Body", as notified vide relevant rules.
- That the Director School Education, Jammu/Kashmir shall now onwards forward the up-gradation cases of only those academic institutions/schools, which in addition to other essential requirements shall also fulfill the criterion of successive year/s.
- Henceforth, no provisional affiliation shall be granted in up-gradation and New Establishment cases.
- The Institutions which are located in the heart of city lacking Playground and Examination Hall facilities have to sign a MOU (Memorandum of Understanding) with the nearby Institutions Government or private falling within the vicinity of 3-4 kilometers radius for utilizing the available space of their Playground and Examination Hall.
- It shall be mandatory for all the institutions to submit the application/ files for Extension of Affiliation one year prior to expiry of affiliation as per the Affiliation calendar approved by the Affiliation Committee/JKBOSE.
- If at any stage, it is established that any information/document submitted by the institution is/was fake, forged or misleading, the onus shall lie on part of the institution and JKBoSE shall bear no responsibility for such actions and the decision of the JKBoSE authorities under such circumstances shall be final and binding upon such institutions.
