The heads of all the institutions are advised in their own interest to submit the online applications much before the prescribed dates, preferably before 31st August, 2023 and not to wait till the last date to avoid imposition of late fee and possibility of failure to login on account of heavy load on the website during the last dates. In case any institution fails to apply for Renewal/ Extension of Affiliation within due dates, the consequences, whatsoever, shall lie on part of the defaulter institution(s) and the decision of the J&K BoSE in that respect shall be final and binding upon the institution(s).
