



**THE JAMMU AND KASHMIR BOARD OF SCHOOL EDUCATION,

NOTIFICATION

Whereas, the counselling process for 1st Year of pursuing two year Diploma in Elementary Education (D.El.Ed) Session 2019-21 in Non- Govt., recognized D.El.Ed Institutions duly affiliated with JKBOSE was held w.e.f 09th December 2019 till 30th December 2019 and class work started on 27-01-2020 vide notification no: F(PS-JS/D.El.Ed)/B/JD/2020 Dated:-21-01-2020.

Whereas, during the counselling, eight(8) more colleges were given the opportunity to participate in the counselling provisionally on the directions of Hon'ble Court of J&K at Jammu, subject to the condition that the said institution will complete requisite formalities for grant of Affiliation. In the said counselling, 136 candidates had opted institutions namely Amrit ETT College, Kathua, Bhagat Kabir ETT College & Hill People ETT College for pursuing the D.EL.Ed Two-Year Course for the Session 2019-21. Later on, Affiliation was not granted to these Colleges by the State Affiliation Committee (SAC).

Whereas, All such candidates, who had opted for the said Institutions/Colleges were given an opportunity for exercising their choice for opting other colleges affiliated with JKBOSE for the said course till 19-02-2020 vide Notification No. F(D.El.Ed-Acad/shifting)B/JD/20 dated 14-02-2020 as per JKBOSE norms.

Whereas, in response to this Notification, only 17 candidates out of total 136 candidates approached this Office for allotment of other affiliated colleges as per their choice, while the other left out candidates did not turn up for opting other college/s of their choice. However, on 17-06-2021, only 03 candidates have approached this office to know the name of their Institution, where they have been shifted, after lapse of one and a half year. The guidelines of JKBOSE in this regard are reproduced as under:-

“After counselling, the candidate shall be allotted to the concerned ETT now renamed (D.El.Ed) Institute/s as per the choice of the candidate exercised during counselling. The candidate shall seek admission in the concerned allotted institutes within 30 days after the completion of counselling, failing which the admission of the said candidate/s shall be treated as cancelled. However, if for certain unavoidable circumstances, a candidate is unable to seek admission within the above mentioned prescribed time, the Chairman, BOSE may allow such a candidate to join later on, within reasonable time not exceeding 45 days from the date of completion of counselling process”.

Whereas, the Promoter of one of the Colleges i.e Amrit ETT College, Kathua has filed the writ Petition bearing No.1961/2020 before the Hon'ble High Court of J&K at Jammu for same candidates and for similar relief, which has been dismissed by the Hon'ble High Court vide judgement dated 19-03-2021 and even after the dismissal of the writ petition on 19-03-2021, no candidate approached this office for allotment of other colleges, affiliated with the JKBOSE.

In view of the above, it is hereby notified for information of all the concerned stakeholders that such candidates, who failed to approach this office within the stipulated date (i.e. upto 19-02-2020) for shifting /allotment of other affiliated colleges are not eligible at this time, as their candidature for D.El.Ed 1st Year Session 2019-21 stands cancelled, as per the BOSE norms. As such, no request at this belated stage shall be entertained under any circumstances.
