Sequel to the approval of the Chairman to the resolutions passed by the State Affiliation Committee in its meeting held on 17.04.2018 in the Conference Hall of JK BOSE Campus Rehari Colony Jammu , sanction is hereby accorded to the:-

- Grant of extension in the period of affiliation in favour of 77 (Seventy Seven) Private Educational High/Higher Secondary institutions of Kashmir Division for a period of five(05) years from the Academic Session Oct- Nov. 2017 forming Annexure "A" to this order.
- Grant of up-gradation in favour of 24 (Twenty four)institutions of Kashmir Division up to high/Higher Secondary Level for a period of two years from the Academic Session Oct- Nov. 2017 forming Annexure "A1" to this order.

The affiliation shall strictly be governed by the terms and conditions as laid down vide SRO 123, relevant Govt. orders, BOSE regulations and the resolutions of the State Affiliation Committee meetings passed from time to time.

- A. That the minor deficiencies like introduction of C.P fund, disbursement of salary though banks, improvement of library/laboratory and other minor deficiencies reflected in the said annexure against each institution are to be addressed within a time bound period of three months and the institutions are required to submit the compliance report to Board office within three months otherwise their affiliation shall be treated as cancelled.
- B. There shall be no compromise with safety conditions, therefore three mandatory Statutory Certificates viz Building safety, Fire Safety, and Chemical Safety by the designated authorities are essential for the consideration of the affiliation and the institutions concerned shall be required to submit renewed certificates immediately after expiry of the validity period of said Safety certificates besides the compliance to NBC (National building code) norms are to be ensured.
- C. It shall be binding upon all the Institutions to fulfill all the statutory conditions laid down from time to time.
- D. The financial transactions especially the payment of salary to the Staff is to be made through Bank.
- E. All the private Educational Institutions shall adhere to the fee structure fixed by the Fee fixation Committee of the Govt. failing which they are liable to be disaffiliated.
- F. All schools have to adhere to the conditions imposed by the Competent authorities for safe transportation of students.
- G. The heads of the affiliated Institutions shall keep their infrastructure like the Examination hall and related facilities at the disposal of the BOSE as and when needed and especially at the time of the examinations.

- H. The Academic calendar prepared by the BOSE is to be strictly adhered to. Any deviation thereof will invite imposition of penalty.
- It will be obligatory to stick strictly to the curriculum adopted by the BOSE for all classes and prescribe Books published by the JKBOSE for transaction of the Curriculum and the proper arrangement for co-curricular and extra-curricular activities for the students must be ensured.
- J. To maintain hygiene and sanitation, ensure separate Toilet facilities for both boys and girls. An additional facility of Change room is to be made available to the female staff/students. The First aid facilities are also to be ensured.
- K. Parent Association as required under Norms has to be there along with Managing committee to ensure the Academic development.
- L. The EFP/CPF (whichever is applicable) is to be maintained with the required contribution towards the fund.
- M. It shall be obligatory upon all the affiliated academic Institutions to obtain recognition Order from School Education Department.
- N. The previous period of provisional affiliation is regularized in respect of the extension cases with a token fine of Rs2000/- for each year of their period of provisional affiliation.

The compliance to the above mentioned requirements is obligatory and any deviation thereof will invite penalty, even de-affiliation from JK BOSE.
