
**INSTRUCTIONS & GUIDELINES: -**

- The Concerned students/schools shall visit the BoSE website [www.jkbose.nic.in](http://www.jkbose.nic.in) and the URL will open for filling the RR Forms of Class 9<sup>th</sup> Students. The Complete instructions have been given in BoSE website [www.jkbose.nic.in](http://www.jkbose.nic.in)
- The concerned Heads of the Affiliated Academic institutions shall facilitate and guide the students and ensure that every student of their school correctly enters the data particulars online.
- Disabled candidates having disability of 50 (Fifty percent or more) are exempted from paying Registration Return Fee. However, they shall take a printout of the Registration Return Form submitted online, get it attested by the Head of the Concerned Academic Institution and submit the same in the concerned District/Tehsil Office of the BoSE along with Disability Certificate from the concerned Medical Board.
- Only those on-roll students of Class 9<sup>th</sup> for the Academic Session 2020-22 are eligible for submission of the Registration Returns who shall attain the age of (14) Fourteen plus on the first day of May, 2022.
- The concerned Heads of the Affiliated Academic Institutions shall verify and ensure that all the particulars filled-in by the candidates are genuine and strictly in accordance with the Admission Records before forwarding these (online) to the JKBoSE.
- The particulars of the candidates verified and certified by the concerned Affiliated Academic Institutions shall be recorded in the JKBoSE database as final and no further correspondence or claim whatsoever shall be accepted at later stage on this score.
- All the Heads of the concerned Institutions are informed that they shall submit the checklist of the registered candidates duly attested/authenticated and submit the same in the concerned Board/Sub/Branch/Head Office after making correction/s, if any along with supporting documents.**
- Only those Academic Institutions who are affiliated with the BoSE and in whose favour the facilities for the current Academic Session 2021-22 have been released by the General Section shall be able to transmit the Registration Returns of their on-roll eligible students.

j. The Head of the Institutions shall ensure that the students who have passed class 9<sup>th</sup> for the academic Session 2020-21 in any institution must necessarily be registered from that very institution. Deviation, if any, will be treated as unauthorized admission and warrants action against the concerned Head of the Institution.
