## NOTIFICATION

In continuation to this office notification No. F (Acad-C)relax/Syllabi/X/XI/XII/21 dated 13-08-2021, it is once again notified for further clarification of the students appearing in the ensuing Annual (Regular) Classes 10<sup>th</sup>, 11<sup>th</sup>, and 12<sup>th</sup> Examinations of Kashmir Division/Winter zone areas of Jammu Division/UT of Ladakh and Annual (Regular) Examinations of 2022 of Summer Zone areas of Jammu Division.

- 1- The students shall have to attempt only 70% marks from the question paper which shall be treated as 100% for result computation there by a resultant concession of 30%.
- 2- The theory paper for examination of class 10<sup>th</sup> shall be set as per notification No.F (Acad-C) CBSE-Design/QP/X/21 dated 30-03-21. Accordingly the theory paper in case of main subjects like, 1) English 2) Mathematics, 3) Science, 4) Social Science, 5) Urdu and 6) Hindi shall be of 80 marks only and candidates have to attempt questions having weightage of 56 marks during the examination. 20 marks are reserved for internal assessment as per new scheme of assessment/examination.
- 3- In case of Classes 11<sup>th</sup> and 12<sup>th</sup>, the subjects having no practical course, the question paper shall be of 100 marks and students have to attempt questions having weightage of 70% marks which equals to 70 marks, while as in case of subjects having Practical/Project work/Internal Assessment, the candidates shall have to attempt questions having weightage of 70% marks out of the total theory Marks allotted to such subjects after availing the relaxation of 30% Marks e.g.


In case of subjects having :

Allotted theory Marks	70% Marks to be Attempted by the Candidates equal to :
90 Marks	63 Marks
80 Marks	56 Marks
70 Marks	49 Marks
60 Marks	42 Marks
50 Marks	35 Marks

Further, it is clarified in respect of language papers e.g General English, where the grammar portion consists of questions having parts/sub parts with

different types of items carrying one or half mark per item. For such type of questions, each item under a part/sub part shall be evaluated individually and total attemptation shall be worked out on the basis of total items under various parts/sub parts actually attempted by the candidate. Furthermore, the whole part of the grammar portion and its weightage shall be considered individually only in such cases where there are no sub parts.
