NOTIFICATION

Subject:

Decision regarding declaration of result of Class 10th Annual Regular, 2020-21 (Summer Zone Jammu Division) and Class 10th Bi-Annual/ Annual Private Examination 2020-21 of Kashmir Division & Winter Zone areas of Jammu Division

Reference: Letter No.Edu/Nc-SE/04/2021 dated 17-06-2021 of the Additional Secretary to the Government, School Education Department.

Whereas, the Annual Regular examination 2020-21 of Class 10th for the candidates of Summer Zone Jammu Division could not be concluded & examination of only two papers of the said examination were conducted, besides Class 10th Bi-annual/ Annual Private Examination 2020-21 of Kashmir Division & Winter Zone areas of Jammu Division had to be cancelled as a preventive measure in view of spread of second wave of COVID-19 pandemic.

Now therefore, in order to save the academic future of the students, it is hereby notified as under:-

1. In case of Class 10th Annual Regular Examination 2020-21 of Summer Zone areas of Jammu Division who have appeared in two subjects and passed both the subjects, the average of the percentage of marks obtained by the candidates in the Papers (English and Social Science including Internal Assessment) for which examination has been conducted shall be calculated on the basis of average percentage of marks thus obtained, which shall be awarded in the language Paper viz. Hindi/Urdu. The average of marks in best of the two papers out of the three subjects (English, Social Studies, Hindi/Urdu) shall be worked out and thus the average marks so obtained shall be the benchmark for awarding marks in Science. Further, the average of marks obtained by the candidate in best of two papers out of four subjects (English, Social Studies, Hindi/Urdu & Science) shall be the benchmark for awarding marks in Mathematics.

Illustration: For example a candidate obtains 70% Marks in English and 60% Marks in Social Studies including Internal Assessment. The average percentage shall be (70+60)/2 = 65%. That means, the candidate shall be awarded 65% Marks in Hindi/Urdu. And in case of Science, marks shall be awarded to the extent of average marks of the best two scores out of three subjects (English, Social Studies, Hindi/Urdu) i.e. 70 (E) + 65 (H/U) = 67.5% (Rounded to 68%). Hence 68% marks shall be awarded in Science. Further, in case of Mathematics, marks shall be awarded to the extent of average marks of the best two scores out of 04 subjects (English, Social Studies, Hindi/Urdu & Science) i.e. 70 (E) + 68 (S) = 69%. Hence 69% marks shall be awarded in Mathematics. The marks in the

practical part of the Science Subject shall be awarded in proportionate to the marks awarded in the theory part.

Note: The marks calculated in fractions to the extent of 0.5 & above, shall be rounded to next number (e.g. 35.5 to 35.9 shall be rounded to 36 marks) and fraction below 0.5 shall be deemed to be the same number (e.g. 35.1 to 35.4 shall be rounded to 35 marks).

- 2. In case of Class 10th Annual Regular Examination 2020-21 of Summer Zone areas of Jammu Division, if a candidate had remained absent or declared fail in one of the two above mentioned subject of which the examination was conducted, no proportionate marks shall be awarded and he/she shall have to appear again in ensuing Examination of Class 10th as and when held by the JKBoSE
- 3. In case of Class 10th Bi-Annual/ Annual Private Examination 2020-21 of Kashmir Division, and Winter zone areas of Jammu Division, whose examination could not be conducted due to Covid-19 Pandemic shall be awarded marks on proportionate/ average basis only to all such candidates who have already passed at least two papers during the previous examinations subject to the condition that all such candidates have submitted the permission cum admission forms for the said examination, deposited the examination fee as per the schedule already notified in this regard by JKBOSE and have been found eligible to appear in the said examination. The marks shall be awarded to such candidates as per the below given method:
 - a) In case of candidates having already passed four subjects, the marks in 5th subject shall be given on the basis of average of highest marks scored in any two subjects out of the four subjects.
 - b) In case of candidates having already passed three subjects, the marks in 4th subject shall be given on the basis of average of the highest marks scored in any two subjects out of the three subjects and likewise marks in 5th subject shall be given on the basis of average of the highest marks scored in any two subjects out of the four subjects
 - c) In case of candidates having already passed two subjects, the marks in 3rd subject shall be given on the basis of average of marks scored in the two subjects already passed and marks in 4th subject shall be given on the basis of average of highest marks scored in any two subjects out of the three subjects and marks in 5th subject shall be given on the basis of average of highest marks scored in any two subjects out of the 04 subjects.
- 4. The candidates falling in category viz Fresh/ Additional Subject Cases/ Failure & Reappear (having passed only one subject), shall have to appear in the examination likely to be conducted in the month of August, 2021.
- 5. Those candidates who are not satisfied and ready to accept their results declared after awarding marks on average basis as detailed above at (1) & (2), shall be given a chance to appear in the examination as and when the same is feasible to be conducted.
- 6. The candidates having vocational optional subject, shall appear in external practical assessment to be conducted by Sector Skill Council of India as and when, the Covid-19 pandemic situation improves and conditions become conducive.

That the promotion of the candidates shall be subject to the condition that, if for any reason at any stage of time in future, it is found that the candidate/s was/were not eligible for appearing in Class 10th examination and has been granted promotion the JKBOSE reserves the right to cancel his/her/their promotion instantaneously without any prior notice.
