## CIRCULAR

It is hereby circulated for information of all the Heads of the Affiliated Govt/Pvt. Institutions of Summer Zone and Winter Zone areas of Jammu Division who had already deposited the fee of Rs.200/- per candidate as token fine vide Circular No. **F(Regn-B)/Corr./SZ/9<sup>th</sup> /JD/21**, Dated: 01-02-2021 and No. F(JSE/R/PCA)JD/20, dated. 18-11-2020 for making correction in Registration particulars including D.O.B, for the Session 2019-21,S/Z and 2018-20, W/Z and the said correction/s have not been carried out due to certain reasons. In order to facilitate such students, whose result of Class 10<sup>th</sup> (Regular) was declared on 29-06-2021 in case of S/Z and 01-03-2021 in case of W/Z with incorrect particular despite of depositing Rs.200/ as token fine, that they will submit their document viz 8<sup>th</sup> Class DIET Marks Card in the Board Office Jammu/ Sub/Branch Office concerned upto 25-08-2021 alongwith photocopy of Bank Voucher amounting to Rs.200/ already deposited into Board chest for making correction in particular including D.O.B as well, as a "onetime exception".
