## NOTIFICATION

Sub:- Decision regarding Annual (Pvt.)/ Bi-Annual 2021 Examination of SSE (Class 10<sup>th</sup>), HSE-I (Class 11<sup>th</sup>) and HSE-II (Class 12<sup>th</sup>) of Summer Zone Jammu Division.

Ref:- Letter No: EDU/NC-SE/04/sgr/e-22531/2021 dated:- 29-07-2021 of Additional Secretary, School Education Department.

It is hereby notified for the information of all concerned that the result of the candidates of SSE (Class 10<sup>th</sup>), HSE-I (Class 11<sup>th</sup>) & HSE-II (Class 12<sup>th</sup>) Annual (Pvt.) / Bi-Annual 2021 of Summer Zone Jammu Division, who have already submitted their Permission cum Admission Forms that their result shall be declared on the same analogy, as adopted for declaration of result of class 10<sup>th</sup>, class 11<sup>th</sup> and class 12<sup>th</sup> in respect of the candidates of Kashmir Division, Jammu Division (Winter Zone Areas) and Ladakh, i.e. the candidates who have already passed two or more subjects shall be promoted to next higher class as per the following mechanism:-

- a. In case of candidates having already passed four subjects, the marks in 5<sup>th</sup> subject shall be given on the basis of average of highest marks scored in any two subjects out of the four subjects.
- b. In case of candidates having already passed three subjects, the marks in 4th subject shall be given on the basis of average of the highest marks scored in any two subjects out of the three subjects and likewise marks in 5th subject shall be given on the basis of average of the highest marks scored in any two subjects out of the four subjects.
- c. In case of candidates having already passed two subjects, the marks in 3rd subject shall be given on the basis of average of marks scored in the two subjects already passed and marks in 4<sup>th</sup> subject shall be given on the basis of average of highest marks scored in any two subjects out of the three subjects and marks in 5<sup>th</sup> subject shall be given on the basis of average of highest marks scored in any two subjects out of the four subjects.
- The candidates who had to appear as Fresh/ Subject Change Cases/
  Additional Subject Cases/Statutory concession cases/ Improvement
  Cases/ Failure & Reappear (having passed only one subject), shall have to

appear in the examination, date of which shall be notified soon after declaration of result.

- > Those candidates who are not satisfied and ready to accept their results declared after awarding marks on average basis as detailed above shall be given chance to appear in the examination as and when the same is feasible to be conducted.
- > The candidates having vocational optional subject, shall appear in external practical assessment to be conducted by Sector Skill Council, dates of which shall be notified soon after declaration of result.
- > That the promotion of the candidates shall be subject to the condition that, if for any reason at any stage of time in future, it is found that the candidate/s was/were not eligible for appearing examination and has been promoted, the JKBOSE reserves the right to cancel his/her/their promotion instantaneously without any prior notice.
