General Instructions regarding eligibility for Migration to J&K BOSE:

- Students having qualified 9th/ 10th/11th or its equivalent examination through CBSE or any other recognized University/ Board of the country.
- Session of study shall be coincides with the study session of the J&K BOSE,
- It is mandatory to pass/ complete Class 9th/10th and Class 11th /12th in two academic sessions.
- Candidates placed in Re-appear/ Compartment category in any of the opted subjects by CBSE or any other recognized University/ Board of the country are not eligible to seek admission in Regular capacity in next higher class in any Affiliated Academic Institution of the J&K BOSE. Such candidates, if desire to appear afresh in the same class, i.e., Class 10th,11th or 12th, as the case may be, through this Board shall be allowed to do so in a Private capacity only, subject to fulfilment of other formalities laid down in the regulations.
- Candidates are advised to fill in the correct particulars, as mentioned in the Marks Certificates of CBSE, and the same upon certification from the Institution (where seeking admission) shall be recorded as final in the J&K BOSE database. No further claim, whatsoever, shall be accepted afterwards.

- *The candidates who submit the online Eligibility requests shall approach the concerned District/ Tehsil Offices of the BOSE along with all the relevant documentary proofs in support of Migrations within the dates prescribed overleaf for physical verification of documents.*
- *The concerned Heads of the District/ Tehsil Offices of the BOSE shall manually and scrupulously verify the documents submitted by the candidates. Further, they shall explore the option of verification of Class 10th (conducted by CBSE/ other Recognized Boards) through online mode from the official websites of the concerned Boards. However for Class 9th and 11th, as the case may be, the verification shall be acquired from concerned schools.*
