Pursuant to the promulgation of the Government Order No. 119-Edu of 2017, dated. 15-03-2017 (Re-structuring of examination system) read with Notification bearing endorsement No. F(Acad-C)Adms/XI-XII/18, dated. 24-09-2018 issued by the Director Academics, JKBOSE, it is hereby, notified for information and follow-up of all the concerned that,

a. The students who, after the declaration of the result of the Higher Secondary Part-I (Class 11th) Annual/Regular,2021 Examination have been declared unsuccessful (reappear/fail) and are provisionally admitted in Higher Secondary Part-II (Class 12th) shall be permitted to continue their classes/studies in HSP-II(Class 12th) till their results of Annual (Private) Bi-Annual, 2021-22 for Class 11th are declared.

b. Students who after the declaration of Annual (Private)Bi-Annual,2021-22 fail to qualify their Higher Secondary Part-I (Class 11th), their provisional admission in HSP-II (Class 12th) shall stand cancelled automatically.

c. <u>Such students, only, shall be eligible for regularization of their admissions</u> and allowed to continue their studies in HSP-II (Class 12th), who are declared successful in Higher Secondary Part-I (Class 11th).
