
Pursuant to the promulgation of the Government Order No. 119-Edu of 2017, dated. 15-03-2017 (Re-structuring of examination system) read with Notification bearing endorsement No. F(Acad-C)Adms/XI-XII/18, dated. 24-09-2018 issued by the Director Academics, JKBOSE, it is hereby, notified for information and follow-up of all the concerned that,

- The students who, after the declaration of the result of the **Higher Secondary Part-I (Class 11<sup>th</sup>) Annual/Regular, 2021 Examination** have been declared unsuccessful (reappear/fail) and are provisionally admitted in **Higher Secondary Part-II (Class 12<sup>th</sup>)** shall be permitted to continue their classes/studies in **HSP-II (Class 12<sup>th</sup>)** till their results of Annual (Private) Bi-Annual, 2021-22 for Class 11<sup>th</sup> are declared.
- Students who after the declaration of **Annual (Private) Bi-Annual, 2021-22** fail to qualify their **Higher Secondary Part-I (Class 11<sup>th</sup>)**, their provisional admission in HSP-II (Class 12<sup>th</sup>) shall stand cancelled automatically.
- Such students, only, shall be eligible for regularization of their admissions and allowed to continue their studies in HSP-II (Class 12<sup>th</sup>), who are declared successful in Higher Secondary Part-I (Class 11<sup>th</sup>).
