Eligibility:

1. Eligible Re-appear/ Failure candidates of Bi-Annual, 2017/ Annual/Regular, 2018-19 (JKSOS).
2. Re-appear/ Failure candidates of all other previous sessions (JKSOS).


General Instructions:

1. The Permission-Cum-Admission Forms shall be available in the concerned Divisional/ District/Tehsil Offices of the BOSE and shall be issued to the Authorized representative/ Admission In-Charge of the Accredited Centres of J&K, SOS against payment of Rs.20/- as cost of PCA Form.
2. The candidates are directed to strictly fill in their registered particulars and affix one latest digital coloured photograph on their respective Permission-Cum-Admission Forms and submit the same in their respective Institutions.

Instructions for Heads of the Affiliated Academic Institutions:

The Heads of the Institutions are instructed to:



3. Furnish an undertaking and ensure that:
 - c. no proxy or any fake attestation is executed from their Institution and shall keep information regarding the candidates appearing through their respective schools by reference of the school sent-up readily available.
 - d. the Registered Particulars of five candidates only are filled on each side of the Enrollment sheet.
4. Cell numbers of each candidate shall be necessarily recorded on the enrollment sheets.
5. Affix latest digital coloured photograph of each candidate against his/her particulars on the Statement of Enrollment duly signed and stamped, as well as on the sent-up list which remains with the Institution for record and reference.
6. Cover the photographs with quality transparent adhesive tape on the Statement of Enrollment to avoid chances of misuse and impersonation.

7. To deposit the prescribed fee, of their eligible candidates, in the designated Branch of the J&K Bank Ltd., Lal Mandi in the shape of "Bank-Slip" to be obtained from the District Offices, Lal Mandi, Srinagar. However, in case of Jammu Division, the stakeholders can contact the Divisional Office, Jammu/ District/ Tehsil Offices of Jammu Division for deposition of fee.
8. Submit the Permission-cum-Admission Forms and Statements of Enrollment, complete in all respects & duly filled in on the prescribed formats along with forwarding letters, in triplicate, in the **District Office, Lal Mandi, BOSE** through their Authorized representative/ Admission In-Charge only. In case of Jammu Division, the concerned are informed to approach the concerned BOSE Offices.
9. The forwarding letters must indicate the number of candidates (enrolled & appearing) subject wise and description of fee deposited in the Bank. Subject-wise micro-pack be also indicated below on each page of the Statement of Enrollment.

Note:- In case the last date/s for submission of returns/ fee is declared as holiday, the next working day shall be treated as the last date.
