## NOTIFICATION

Subject: Decision regarding declaration of result of HSP-I (Class XI) Annual Regular, 2021 (Summer Zone Jammu Division) and HSP-I (Class XI) Bi-annual/ Annual Private Examination 2020-21 of Kashmir Division, Winter Zone areas of Jammu Division

Reference: Letter No.Edu/Nc-SE/04/2021 dated 17-06-2021 of the Additional Secretary to the Government, School Education Department.

Whereas, the Annual Regular examination 2020-21 of HSP-I (Class XI) for the candidates of Summer Zone Jammu Division and HSP-I (Class XI) Bi-annual/ Annual Private Examination 2020-21 of Kashmir Division & Winter Zone areas of Jammu Division had to be cancelled as a preventive measure in view of spread of second wave of COVID-19 pandemic.

Now therefore, in order to save the academic future of the students, it is hereby notified as under:-

- 01. That all the eligible Candidates who had to appear in the HSP-I (Class XI) 2021/Annual Regular Examination, falling under summer zone of Jammu Division (that has been cancelled ) and have been allotted/issued Roll No Slips are PROMOTED to HSP-II (Class XII) this Session only (Annual Regular 2021).
- 02, That in case of all those candidates who had to appear in HSP-I (Class-XI) Biannual / Annual Private Examination 2020-21 of Kashmir Division and Winter Zone areas of Jammu Division, but their examination could not be conducted shall be awarded marks on proportionate/ average basis only to all such candidates who have already passed at least two papers during the previous examinations subject to the condition that all such candidates have submitted the permission cum admission forms for the said examination, deposited the examination fee as per the schedule already notified in this regard by JKBOSE and have been found eligible to appear in the said examination. The marks shall be awarded to such candidates as per the below given method;
  - In case of candidates having already passed 4 subjects, the marks in 5th subject shall be given on the basis of average of highest marks scored in any two subjects out of the four subjects.
  - In case of candidates having already passed three subjects, the marks in 4th subject shall be given on the basis of average of the highest marks scored in b) any two subjects out of the three subjects and likewise marks in 5 th subject shall be given on the basis of average of the highest marks scored in any two subjects out of the four subjects.
    - In case of candidates having already passed two subjects, the marks in 3rd subject shall be given on the basis of average of marks scored in the two subjects already passed and marks in 4th subject shall be given on the basis of average of highest marks scored in any two subjects out of the three subjects

and marks in 5 th subject shall be given on the basis of average of highest marks scored in any two subjects out of the four subjects.

- The candidates viz Fresh/ Subject Change Cases/ Additional Subject Cases/ d) Improvement Cases/ Failure & Reappear (having passed only one subject), shall have to appear in the examination likely to be conducted in the month of August, 2021.
- 03. Those candidates, who are not satisfied and ready to accept their results declared after awarding marks on average basis as detailed above from point (a) to (c), shall be given a chance to appear in the examination as and when the same is feasible to be conducted.
- 04. That the promotion of the candidates shall be subject to the condition that, if for any reason at any stage of time in future, it is found that the candidate/s was/were not eligible for appearing in HSP-I (Class XI) examination the JKBOSE reserves the right to cancel his/her/their promotion instantaneously without any prior notice.
