Besides above, candidates of Higher Secondary Part-II (Class 12<sup>th</sup>) studying in the Affiliated Academic Institutions of the Kashmir Division and those eligible candidates who are intending to migrate to J&K BOSE from other Recognized Boards in Class 12<sup>th</sup>, for the current Academic Session 2021-22, and are desirous to change their subject/s, as per the combination of subjects/ scheme of studies, shall be allowed to do so after completion of required formalities/ deposition of the requisite fee of **Rs.500/-** and submit the **PCA Forms of the corresponding changed subject/s in HSP-I (Class 11<sup>th</sup>) on normal prescribed fee, till 25<sup>th</sup> May, 2022.**

Notwithstanding the result for HSP-II (Class 12<sup>th</sup>) Annual/ Regular, 2022 shall be kept withheld under Disputed Eligibility category till they qualify the corresponding changed subject/s in HSP-I (Class 11<sup>th</sup>).
