Whereas, a Circular was issued on 16-10-2021 in which all the Promoters of Non-Govt. D.El.Ed Institutions affiliated with the JKBOSE were directed to start 2^{nd} Year D.El.Ed classes Session 2019-21 for all eligible candidates through **OFFLINE** mode.

Whereas, this office again issued Circular on 01-12-2021 wherein all the Promoters of Non-Govt. D.El.Ed Institutions affiliated with the JKBOSE are impressed to start 2nd Year D.El.Ed classes Session 2019-21 forthwith for all eligible candidates through **OFFLINE** mode.

Whereas, this office again issued Circular on 22-01-2022 wherein all the Promoters of Non-Govt. D.El.Ed Institutions affiliated with the JKBOSE are impressed to start 2nd Year D.El.Ed classes Session 2019-21 forthwith for all eligible candidates through **ONLINE** mode due to hike in Covid-19 cases.

Whereas, this office again issued Circular on 25-02-2022 wherein all the Promoters of Non-Govt. D.El.Ed Institutions affiliated with the JKBOSE are impressed to start 2nd Year D.El.Ed classes Session 2019-21 forthwith for all eligible candidates through **OFFLINE** mode.

Whereas, this office has received numerous reports that no classwork through offline mode is going on in said colleges despite clear instructions from this office.

Whereas, this office has constituted the inspection teams on 11-05-2022 for onspot inspection to ascertain the factual position whether the D.El.Ed 2nd Year classes Session 2019-21 were functioning or not. The teams have submitted that no classwork is going on in the institutions except some colleges with low attendance.

Whereas, due to non-compliance of the Circulars in letter and spirit, this office again issued a notice on 19-05-2022 to start the offline classwork for a period of three months to complete the attendance and syllabus prescribed for conduct of D.El.Ed exam but all in vain.

Whereas, Inspection teams were again constituted on 02-07-2022 to know the factual position whether the D.El.Ed $2^{\rm nd}$ Year classes Session 2019-21 were functioning or not. Its a surprise for us that all Inspection teams have reported that no candidate was found in maximum colleges and very few with thin attendance were found in two or three colleges.

Whereas, Asstt. Secretary, Sub-Office Kathua was also directed to visit all D.El.Ed Colleges personally to check whether offline classes are going on in the colleges. She has also stated that no student of 2^{nd} Year D.El.Ed Session 2019-21 is found in the D.El.Ed colleges.

Whereas, D.El.Ed is a Regular professional course and JKBOSE is not in position to conduct the aforesaid examination unless and until regular minimum attendance of the students and syllabus is completed.

The authorities have taken a very serious view for non-compliance of the Circulars issued by this office from time to time by the Promoters of Non-Govt. affiliated D.El.Ed Institutions. Keeping in view the future of the candidates , authorities have pleased to issue a final notice to conduct regular classwork in offline mode for atleast one month with double shift w.e.f 01-09-2022 to 30-09-2022 for all students, so that, process for conducting the exams is started w.e.f 01-10-2022 otherwise the JKBOSE shall conduct the exams of only those candidates who shall attend regular classes and complete attendance /syllabus upto 30-09-2022 duly authenticated by the inspection teams.
