- Candidates whose result of HSP-I (Class 11<sup>th</sup>), earlier kept withheld under Disputed Eligibility category, has been declared after having cleared their backlog of SSE (Class 10<sup>th</sup>) in Annual (Private)/ Bi-Annual, 2019-20 or 2020-21 examinations.
