
Subject:- Schedule for online submission of Permission-cum-Admission Forms for Higher Secondary Part-I (Class 11th) for Annual/Regular, 2021 Examination.

It is hereby promulgated for information and follow-up of all the concerned stakeholders in general and the candidates in particular who are currently on-rolls in Higher Secondary Part-I (Class 11th) for the current Academic Session 2020-21 in the Affiliated Academic Institutions of the Kashmir Division, including District Kargil and are eligible to appear in the ensuing Annual/Regular, 2021 Examination, that the process for Online submission of Permission-cum-Admission Forms shall be available through BOSE website www.jkbose.nic.in as per the below notified-schedule.

Instructions and guidelines:


- The concerned students/ school Incharges shall visit the BOSE website www.jkbose.nic.in for submission of Permission-cum-Admission Forms. The URL for the same shall be available on the website for submission of PCA Forms through students / schools.
- The concerned students/ schools can submit the PCA Forms through their valid e-mail id / school id under student login window/ office login window.
- After selecting the "Examination Form" option the Registration Number of the eligible candidate is to be entered after which the Registered particulars will automatically be fetched. However the Heads of the Academic Institutions shall ensure that the eligible students / dealing assistants of their respective schools, enter rest of the fields correctly.
- In case of non-availability of the internet facility to the candidates, it shall be the responsibility of the concerned schools to guide them and submit the PCA Forms of their respective candidates. However no additional amount shall be charged by the Institutions.
- Disabled candidates, having disability of (50)Fifty percent or more, are exempted from paying the examination fee. However, they shall take a printout of the PCA Form submitted online, get it attested by the Head of the Concerned Academic Institution and submit the same in the concerned District/ Tehsil Office of the BOSE alongwith Disability Certificate from the concerned Medical Board.
- The concerned Heads of the Affiliated Academic Institutions shall verify and ensure that the subjects opted and particulars filled-in are genuine and strictly in accordance to the Renewal R.R / Admission Records before forwarding these (online) to the JKBOSE.
- The Heads of the Institutions are instructed to submit the PCA Forms of only those candidates whose Renewal Registration Returns, for the Academic Session 2020-21, have been submitted in the respective BOSE Offices.

- h. A list of the students who submit the PCA Forms online, shall be made available in the "school log in" of the respective schools. The concerned schools shall submit the authenticated copy of the same to the concerned BOSE Offices within (02) working days. The BOSE Offices shall compare the same with the Renewal Registration Return enrollments submitted offline, and report discrepancies, if any, to the Joint Secretary, Examinations, immediately.
- i. The particulars/ data of the candidates verified and certified by the concerned Affiliated Academic Institutions shall be recorded in the JKBOSE database as final and no further correspondence or claim, whatsoever, shall be accepted at later stage on this score.
- j. Only those Academic Institutions who are affiliated with the BOSE and in whose favour the facilities for the current Academic Session 2020-21 have been released by the General Sections shall be able to transmit the PCA Forms of their on-roll eligible students.
- k. Further instructions/ guidelines shall be made available on the website.
