Subject: - Disaffiliation of Shiv Shiksha Kender High School, Gho Brahmana, Samba (J&K).

Sequel to the approval of the authorities the institution namely Shiv Shiksha Kender High School, Gho Brahmana, Samba (J&K) is hereby disaffiliated with immediate effect for violating the provision of J&K BoSE Act 1975 and its regulations. The said institution now ceases to be affiliated with J&K Board and its name has been struck off the list of affiliated institutions. The promoter of the said institution is disallowed to admit any student / run classes from 9th to 12th standard for any Board examination in this institution.

To safeguard the academic interests of the students the eligible old failure/ reappear/ backlog students of this institution (if any) shall get their applications/ Admission-cum-permission forms attested through the Government Hr. Sec. School, Gho-Brahmana, Samba if they intend to apply for any Board service in future. The promoter of the institution is directed to maintain the complete record of the students of his institution from 9th to 12th for ever. As such, all the stake holders in general and the students in particular are hereby informed that they shall not deal with this institution for purpose of admission or examination for class 9th to 12th and anyone doing so shall be doing it in his/her own capacity and under such circumstances JKBoSE shall not bear any responsibility.
