**CIRCULAR**

It is circulated for information of all the promoters of affiliated D.El.Ed Institutions that the designated committee constituted for checking /scrutinizing the records of D.El.Ed 1<sup>st</sup> Year Session 2019-21 furnished by the respective D.El.Ed. Institutions have observed the following deficiencies, which are required to be fulfilled :-

- That, CD/S/DVD/s/Pen Drives provided by the respective D.El.Ed institutions have not reflected the platform/means for video-conferencing i.e. Zoom, Google Meet, Whats App etc. used for conducting the online classes. Relevant data regarding date of constitution of online groups, date of starting online classes, date-wise schedule of lessons/conduct of online classes and no. of participants joined/attending said online classes has not been provided by the concerned D.El.Ed Institutions.
- That, from the CD/s enclosed with the files it seems subject-wise course material provided by all the institutions is not sufficient and proper material has not been provided to the students.
- That, the CD/s/ DVD/s provided by some of the institutions are found blank.
- That, the assignments appended in the file are not of all the enrolled candidates.
- That, being a professional course, Teaching Practice is mandatory part to be completed in proper manner, the records/photographs submitted by the promoters are incomplete in respect of dates, time and name of school preferably Govt. School.
- That, there is mismatch in name of the students mentioned in the Allotment lists and Bio-Metric attendance in respect of some of the students which needs to be cleared.
- That, the Bio-Metric attendance provided by the promoters of the colleges is also incomplete.

- That, No. of deficiencies viz. 10<sup>th</sup>/12<sup>th</sup> class marks card, Migration certificate/ID Proof etc. mentioned in the allotment list of the candidates have not been cleared till date.

The Board intends to conduct the D.El.Ed 1<sup>st</sup> Year Exam Session 2019-21 in the last week of Jan 2021 keeping in view the academic career of the students. It is as such impressed upon all the concerned promoters of D.El.Ed colleges to clear the above discrepancies related to their respective college within a week's time i.e. upto 29<sup>th</sup> Dec 2020 positively.
